Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Show Cause Notice of even number dated 28.10.2025, the Secretary Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose a major penalty of **"Dismissal from Service"** upon **Mr. Ibtisam-ur-Rehman**, AEN-I (BS-17), Pakistan Railways Karachi Division in accordance with Rule 4 read with para 3(e) of Civil Servants (Efficiency & Discipline) Rules 2020.

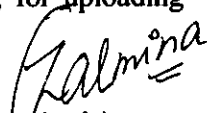
