Consequent upon finalization of disciplinary proceedings initiated under civil servants (Efficiency and Discipline) Rules, 2020 vide order of inquiry and charge sheet of even number dated 19.12.2022, the Secretary/ Chairman Railways, as Authority in terms of rule 2(1)(c) of Civil Servants (Efficiency and Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose major penalty of **"Dismissal from Service"** upon Mr. Muhammad Ismail, Guard-Gr-I (BS-14), Pakistan Railways, Sukkur in accordance with Rule 4 of sub rule (3) (e) of Civil Servants (Efficiency & Discipline) Rules, 2020.
