Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Order of Inquiry and Charge Sheet of even number dated 15.04.2021, the Prime Minister being Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency and Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose major penalty of "Dismissal from Service" upon Mr. Ghulam Dastagir Khan Baloch, a BS-20 Officer of Railways (Commercial & Transportation) Group, in accordance with Rule 4 of Sub Rule (3) (e) of Civil Servants (Efficiency & Discipline) Rules, 2020.

Mr. Ghulam Dastagir Khan Baloch, a BS-20 Officer of Railways (Commercial & Transportation) Group has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.
