NOTIFICATION

No. 1(1)/Dis/2024(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Show Cause Notice of even number dated 12.01.2024, the Secretary Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose major penalty of **“Reduction to a lower post and pay scale from the substantive or regular post, for a period of three years”** upon Mr. Faisal Manzoor, (BS-18), Ex. Dy. MCP/Stat, P.R, HQs Office, Lahore under Rule 4 (3) (b) of the Civil Servants (Efficiency and Discipline) Rules, 2020. Furthermore, the officer is allowed to join duty.

2. Mr. Faisal Manzoor (BS-18), Ex. Dy. MCP/Stat, P.R, HQs Office, Lahore has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.
